For those items identified and considered in the Part 2 EAF, the impact of the sale of the Switzkill Farm Property (Tax Parcel ID: #90.-1-16.100) is considered a "None, or low impact" with regard to impacts. The action sells surplus Town property to the County of Albany. All existing conservation easements and development restrictions will be maintained through the sale of the land.
