New Business:

- 1. Hilltown Healthcare/ Anthony Martin: 1705 Helderberg Trail (SBL# 78.2-1-10) Business Sign Approval / Historic Review
- Sarah Martin explained that they want to put up a sign for the Dr. office that is 30"x48" with the posts for the sign to match the color of the office building.
- Chairman Martin referred the Hilltown Healthcare Application to the ZBA for an Area Variance, as the dimensions of the sign they proposed exceeded the 6 Sq. ft that are allowed for the Historic District. Chairman Martin gave the Applicant the option to keep the 10 sq ft. sign and go through the process with the ZBA or reduce the sign dimensions and continue with the Planning Board and the Historic Review.

Large Scale Solar Project, if members of the Planning Board would like to attend. Chairman Martin also let the board know that with this project unlike others that the ZBA is the lead agency for the project, but that the Planning Board will still be involved because it will require site visits.
